SBA Economic Injury Disaster Loans Available in Maryland Following Secretary of Agriculture Disaster Declaration for Excessive Rain

ATLANTA - The U.S. Small Business Administration announced today that federal Economic Injury Disaster Loans are available to small businesses, small agricultural cooperatives, small businesses engaged in aquaculture and private nonprofit organizations located in Caroline, Dorchester, Kent, Queen Annes, Wicomico and Worcester counties in Maryland as a result of the excessive rain from Sept. 29, 2016 through Oct. 10, 2016.

“These counties are eligible because they are contiguous to one or more primary counties in **Delaware**. SBA recognizes that disasters do not usually stop at county or state lines. For that reason, counties adjacent to primary counties named in the declaration are included,” said Frank Skaggs, director of SBA’s Field Operations Center East in Atlanta.

Under this declaration, the SBA’s Economic Injury Disaster Loan program is available to eligible farm-related and nonfarm-related entities that suffered financial losses as a direct result of this disaster. With the exception of aquaculture enterprises, SBA cannot provide disaster loans to agricultural producers, farmers, or ranchers.

The loan amount can be up to \$2 million with interest rates of 2.625 percent for private nonprofit organizations and 4percent for small businesses, with terms up to 30 years. The SBA determines eligibility based on the size of the applicant, type of activity and its financial resources. Loan amounts and terms are set by the SBA and are based on each applicant’s financial condition. These working capital loans may be used to pay fixed debts, payroll, accounts payable, and other bills that could have been paid had the disaster not occurred. The loans are not intended to replace lost sales or profits.

Applicants may apply online using the Electronic Loan Application (ELA) via SBA’s secure website at <https://disasterloan.sba.gov/ela>.

Completed loan applications must be returned to SBA no later than **Jan. 17, 2018**.
